CALENDAR DESCRIPTION

"This course investigates physical aspects of natural hazards that affect people and society and will focus on the natural systems and processes that cause climate variability and change, floods, earthquakes, volcanoes, landslides, hurricanes, tornados and other natural disasters. "

OVERVIEW

This course investigates the components and processes that contribute to naturally hazardous environments. We will focus on the forces and processes driven by internal and external sources of energy that cause floods, earthquakes, volcanoes, landslides, hurricanes, tornadoes and other natural disasters. The course includes a discussion of significant events in the geologic and historical record as well as future hazard potential and how Geographers are working toward understanding these issues and developing strategies for mitigation and adaptation. We look at the risks humans face in different regions, including local hazards, our contribution to geologic hazards, and how we can minimize and cope with future events.

LEARNING OBJECTIVES

This course aims to introduce and enhance the learning objectives identified by the University of Guelph and the Department of Geography, Environment & Geomatics. Specifically, in this course, students will:

- Develop a comprehensive *depth and breadth of understanding* of the core concepts and principles that create and trigger natural hazards.
- Critically and *independently* recognize, synthesize and evaluate diverse sources of knowledge, arguments and approaches pertinent to exploring elements of geoscientific problems
 - Investigate complex real-world challenges using appropriate concepts, methods, and tools from the geographical sub-disciplines.
 - Recognize and identify the societal relevance of geographical knowledge and apply it to real-world human-environment issues.
- Develop Google Earth Skills for geographic analysis

Each topic will be covered through a combination of lectures, readings, and class discussions.

Each week students will complete an online quiz based on the lecture and assigned readings for that week; students are responsible for preparing and completing these quizzes in the timeframe stipulated.

There are two short individual assignments during the term based on recent or notable hazards. Please refer to CourseLink for more details and the deadlines

of these assignments.

COURSE EVALUATION

The final grade will be assessed from weekly review Quizzes completed online (10%), two Assignments (15% each, 30% total), and two tests a Midterm (25%) and the Final exam (35%). Quizzes, CourseLink discussions and exams are based on information presented in asynchronous micro-lectures and discussed in weekly synchronous meetings. The midterm is online and in week 7, the final exam is focused primarily on the second half but has some cumulative content and is written during the exam period. More details will be provided on CourseLink.

Students with a **documented conflict** for any tests need to see me **at least two weeks** prior to arrange an alternative time, there is no guarantee that this will be accommodated, but ensuring that you address the issue several weeks in advance will certainly assist the

process.

Weekly Review Quizzes – worth 10%, completed online

The weekly review quizzes are an incredible opportunity for students to review and 'test' themselves on the relevant material at a relatively frequent pace. The quizzes in total are worth 10% of the final grade in the class. The quizzes are used to incentivize engagement with the course material one more time. So if you read the assigned readings before you participate in lectures, take helpful notes of the reading and lecture material, and review your notes each week that is approximately five points of engagement with the material. Adding the quiz makes it six points. I think these points of engagement with the material are vital to an in-depth and comprehensive understanding of complex concepts in GEOG*1350. So, the quizzes might feel like extra work – and they should – because the whole point was to get you to engage with the material one more time. Furthermore, the quiz questions help me to gauge student comprehension and usually reflect the most important or challenging ideas and concepts covered during that week. Finally – quiz questions are often re-used on the exams – so in case you needed one more reason to pay attention to them, they will likely help you out with the tests.

The lowest three quiz grades are dropped before the Quiz component of your final grade is calculated. I do this to cover instances where quizzes are missed due to losing track of time and missing the deadline, computer or internet issues, or illness. Therefore, **there are no extensions or second attempts**. If you do all your quizzes, then the lowest three scores are dropped, so you have an opportunity to identify concepts or ideas that need further work to understand without it affecting your final grade.

The quizzes are available from Friday 8PM to the following Monday 2PM.

Assignments – 15% each, 30% total

These assignments are an opportunity for you to demonstrate to us that you understand key concepts. More details about the assignments will be presented inclass and on CourseLink.

Your assignments must be submitted through Dropbox on CourseLink. Late assignments (without prior approval by your GTA) will be penalized at a rate of **10%** of the assignment's value per day. This course uses Turnitin to help encourage academic integrity.
