Introduction and Course Overview:

Geographical Research Methods is intended as a forum for first year MA students to develop their research projects. GRM I (6090) supports MA students as they contextualize and scope a research area and identify a research aim. Students are required to prepare and present a context paper in which they identify and critically engage bodies of literature relevant to their research topic. The ultimate aim of the paper is to help students identify a research problem and shape a relevant and meaningful research aim and objectives. GRM II (6091) supports students as they design a research program. Students are require to prepare, present and defend a research proposal. In weekly seminars, the courses also aim to expose students to elements of research design and methodology (6090) and to research and analytic methods (6091).

Objectives:

The objectives of this course are to:

- 1) Identify bodies of knowledge relevant to a chosen research topic/question
- 2) Situate your research topic relative to debates (theoretical, methodological, empirical) in the literature
- 3) Demonstrate broad critical understanding of literatures and other contexts (e.g., policy) relevant to your topic
- 4) Articulate a clear research problem and identify a research aim
- 5) Develop an understanding of the basic elements of research design

Course Format:

Seminars will be held (information withheld) in the Fall semester. Attendance at the seminars is required of all students registered in the course and active participation is expected. In class we will alternate between lecture, presentations and seminar formats and benefit from a number of guest lectures and panels. A considerable amount of our time in class discussion (including workshopping research topics or discussing these in research) and other activities. While class participation is not a graded component of this class, you are expected to come to class regularly, to have prepared materials in advance, and to participate in class discussions, workshops and other activities. This is your class and I want you to get as much out of these meetings as possible. Research is hard! This course is a forum for you to share the progress (and challenges) of your research journey and to learn from your colleagues' experiences.

Readings:

Readings for this course will be made available through the Ares/course link system at least 1 week in advance.

Assignments & Assessment:

- Context Paper (80%) -- due November 30th
- Context Paper Presentation (20%)—presentations Nov 16 & 23 (see schedule)

Both the **context paper** and **context paper presentation** will be jointly evaluated by the course professor and the student's advisor/advisory committee.
