Submission of Assignments

All coursework assignments will be submitted online through the Courselink platform. All document submissions must be formatted in Word (.doc) or (.pdf) formats.

Late Assignments

For Assignments #1 and #2, the weekend after the Friday due dates is a grace period: late penalties will not accrue until after 11:59pm on the Sunday following the due date. At that point, late assignments will be penalized 5% per day that they are overdue, including subsequent weekend days.

Quizzes and Discussion posts are time sensitive, and so late submissions will not be accepted unless alternative arrangements have been made in advance. Please note that both of these categories of assessment allow for one low grade to be dropped.

Course Policy on Generative AI use

In this course, the use of generative artificial intelligence (GenAl) tools such as ChatGPT, Microsoft Copilot, Gemini, DALL-E etc. is not permitted. All assessments must be the product of your own intellectual effort, without the assistance of GenAl tools. This prohibition applies to all stages of the assigned tasks, including research, outlining, and writing. Violations may be treated as breaches of academic integrity.

Instructors shall not determine if academic misconduct has occurred. This is up to the Associate Dean Academic's office. Instructors shall not assign a grade of zero even if they believe that the student has committed some form of academic misconduct (e.g., copied material from a website like CourseHero) on an assignment or exam.

Instructors <u>can</u> determine if a student has poorly paraphrased and/or improperly cited material and can provide a grade accordingly as long as this is clearly identified as part of the assessment criteria via a rubric or other assessment tools.

Accessibility

Drop Date
