She is an Assistant Professor and Canada Research Chair (Tier II) in Indigenous Environmental Health Governance, Department of Geography, Environment & Geomatics at the University of Guelph in Ontario. She is also Director of the IndigenERA Lab (https://www.indigenera.ca/). Her research interests are to foster a wider understanding of Indigenous worldviews and how these worldviews must inform environmental decisions, specifically as Indigenous peoples are impacted by resource or industrial development. She is a strong advocate for Indigenous data sovereignty and Indigenous-led decision making. She is currently working with Indigenous communities across Canada to develop an Indigenous-led environmental health risk assessment approach.

### **Course Learning Outcomes**

By the end of this course, you will be able to:

- 1. Investigate the impacts of human activities on our planet in the Age of the Anthropocene, with a primary focus on land use and land use change.
- 2. Describe the state of biodiversity in Canada and the major drivers of species endangerment.
- 3. Outline major policies in Canada related to the protection and restoration of biodiversity, including endangered species legislation, protected areas and Indigenous approaches to biodiversity stewardship.
- 4. Discuss the significance of Indigenous Rights in resource development conflicts, including Treaty and Aboriginal Rights as well as Canada's obligations as a signatory to the UN Declaration on the Rights of Indigenous Peoples.
- 5. Discuss the broader social contexts in which environmental decision-making is undertaken, including the significance of Indigenous Knowledge Systems.
- In addition to learning the content, this course is designed to improve your abilities to communicate the nuance and complexity in Indigenoussettler relations clearly and effectively.

Instructors shall not determine if academic misconduct has occurred. This is up to the Associate Dean Academic's office. Instructors shall not assign a grade of zero even if they believe that the student has committed some form of academic misconduct (e.g., copied material from a website like CourseHero) on an assignment or exam.



Instructors <u>can</u> determine if a student has poorly paraphrased and/or improperly cited material and can provide a grade accordingly as long as this is clearly identified as part of the assessment criteria via a rubric or other assessment tools.

### Accessibility
