## **Course Description:**

Undergraduate Calendar description:

"This course explores the ethical dimensions of conducting research and producing knowledge in a context of inclusive and sustainable development. Students will explore the cultural, methodological and ethical challenges of conducting research in vulnerable communities, using concepts of positionality, difference, identity and intersectionality to understand the ways in which they might engage in a mutually-respectful process of research and engagement. The course provides a broad survey of research methods including documentary, observational, qualitative, and quantitative approaches, exploring their key characteristics, strengths and weaknesses and ethical implications of producing knowledge for development. Prerequisite(s): IDEV\*1000"

## **Course Learning Outcomes:**

- Familiarity with a variety of research methods employed in international development studies;
- Ability to engage in ethical reasoning around research in international development studies;
- Ability to understand and interpret common statistical findings reported in research;
- Ability to propose a research project related to international development studies;
- Development of research, reading, and writing skills, as well as critical thinking.

#### **Class Format:**

We will meet twice weekly to discuss course content and engage in collaborative learning activities. We will use Courselink as an electronic resource for announcements, accessing lecture content, accessing activities and supplemental content, discussion, and submitting assignments and quizzes.

In this course, you may screen your own assignments through Turnitin as many times as you wish before the due date.
